Re: Harris County's Method of Distribution Amendment No. 3 – 2015 Floods and Storms CDBG-DR Funds

Dear Dr. Holloway:

The Texas General Land Office Community Development and Revitalization division (GLO-CDR) has completed its review of all materials submitted in support of Harris County's (the County) Amendment No. 3 to the Method of Distribution (MOD) for the 2015 Floods and Storms Community Development Block Grant – Disaster Recovery (CDBG-DR) funds. We are pleased to inform you that the MOD amendment is approved.

GLO-CDR approves the County's reallocation of housing funds to non-housing/infrastructure activities. The terms of the approval are as noted below:

- 1. Acceptance of MOD Amendment No. 3 does not indicate the eligibility or approval of funding for any proposed projects.
- The County's allocation must meet the requirement that 70 percent of the funds benefit low- and moderate-income persons. Projects that do not meet HUD's national objective for benefitting lowand moderate-income persons may not be approved until the County's allocation requirement is met.

2015 Floods Community Development Block Grant – Disaster Recovery Method of Distribution Amendment #3

Justification and Summary

Harris County requests this amendment (#3) to fund additional needed drainage improvements, which will assist in the reduction of flooding in neighboring homes and communities. The 2015 Floods voluntary buyout program has concluded with funding available to assist with an unmet need in the community for improved drainage. This effort is also in line with local advocacy groups and stakeholders, who desire drainage enhancements for vulnerable neighborhoods.

Summary of Amendment to the 2015 Method of Distribution

Harris County proposes to amend its housing allocation by de-obligating \$855,000.00 in housing activity funding and obligating the same amount to its non-housing/infrastructure allocation for an existing non-housing/infrastructure drainage improvement project in a low- to moderate-income community.

The change in the funding will alter the funding distribution percentages from 32 percent housing and 68 percent non-housing to 13 percent housing and 87 percent non-housing (see below table).
