Amendment to Deep East Texas Council of Governments Method of Distribution for Hurricane Harvey CDBG-DR Local Infrastructure Program Funds (MOD Amendment)

Approved December 15, 2022

Purpose:

This Amendment deals with the reallocation of \$101,103 in declined or de-obligated Hurricane Harvey CDBG-DR funds from the original Local Infrastructure MOD. This action amends the Local Infrastructure MOD which was adopted by DETCOG on July 12, 2018 and approved by the GLO on October 3, 2018.

Public Hearing and Comment Period:

The DETCOG Board of Directors conducted a public hearing/public planning meeting on October 27, 2022 and another public hearing on November 22, 2022. Written comments were received from October 21, 2022 until December 9, 2022.

Use of Funds Approved:

At a public meeting on December 15, 2022, the DETCOG Executive Committee adopted a Resolution which is attached and made part of this MOD Amendment. The following reallocation of funds was approved:

The available funds of \$101,103 are reallocated to San Jacinto County, the top-ranked eligible entity. San Jacinto County will be required to confirm acceptance of the reallocation and confirm it has an eligible project that meets the 70 percent LMI requirement; otherwise, the reallocation will go to the next highest-ranking entity that accepts and confirms it has an eligible project. Ranking of entities is as follows:

- 1. San Jacinto County
- 2. Newton County
- 3. Jasper County
- 4. Polk County
- 5. Tyler County

Local Infrastructure Program Method of Distribution Amendment Detail

The COG is required to prepare a method of distribution amendment for the Local Infrastructure Program funds between the eligible cities and counties. The GLO has directed the COG to use a direct allocation technique based on objective and verifiable data. The distribution should be based on, but not limited to, unmet need tied back to Hurricane Harvey damages.

Reallocation Summary

The following is a summary of the reallocation process of funds, including entities that have declined funds, entities that are receiving reallocated funds, and eligible activities.

The purpose of this MOD Amendment is to reallocate \$101,103 in declined MOD funding that was originally allocated to San Augustine County.

The original MOD allocation was based on two distribution factors:

(1) A \$100,000 set aside for each county included Presidential Disaster Declaration DR-4332; and (2) Remainder of funds distributed based on verified housing damages weighted by severity.

It is impossible for the MOD Amendment to include any set asides due to the limited amount of funds available. Therefore, the MOD Amendment allocates all available funding based on verified housing damages weighted by severity.

Because of the requirement to ensure allocation of at least a minimum percentage of funds to HUD-Most Impacted (HUD-MID) Counties and Zip Codes, the MOD Amendment includes a Threshold Factor that an entity is only eligible if a majority of its population is included in a HUD-MID area.

The amount of funding available (\$101,103) and the required minimum allocation (\$100,000) only allow for an allocation to one entity. Eligible entities are ranked based on weighted housing damages. The entire reallocation will go to the top-ranked eligible entity: San Jacinto County.

Reallocation Changes Table:

Attached is a table showing all jurisdictions that have had a change in allocation, including jurisdictions that have declined funds and the jurisdictions that have been reallocated those funds. All allocations must meet or exceed a floor of \$100,000 to help ensure sufficient funds for at least one eligible project.

Low- and Moderate-Income Requirement

Below is an explanation of how the method of distribution meets the 70 percent low- and moderate-income (LMI) requirement for each program. This means that 70 percent of the funds must benefit areas that are 51% or more LMI persons with incomes below 80% of the Area Median Income (AMI).

Before being awarded the reallocated funds, the receiving entity will be required to acknowledge in writing that they will accept the funds, and that they have an eligible project which will meet the 70 percent LMI requirement.

Citizen Participation

Below is a description addressing how the COG complied with their Citizen Participation Plan regarding citizen and nongovernmental organization outreach, and any additional efforts exceeding GLO minimum public participation requirements:

Prior to development of the MOD Amendment, DETCOG conducted a public hearing (Public Planning Meeting) within the Harvey Disaster area. To encourage greater participation, this meeting was held in conjunction with a regular monthly DETCOG Board Meeting which was open to the public and complied with provisions of the Texas Public Meetings Act. In addition, we promoted and conducted an online public information meeting for the convenience of all interested parties. Comments were also accepted by mail, email, or fax. A Solicitation of Public Comment notice was published in English and Spanish in seven newspapers which are published in Jasper, Newton, Polk, San Augustine, San Jacinto, Sabine, and Tyler Counties. Notices were sent to the County Judge and County Clerk of each of these counties with a request for the notice to be posted publicly in the same location that meetings of the County Commissioners Court are posted. Notices were also be sent to Cities, School Districts, the Alabama-Coushatta Tribe of Texas, and local Housing Authorities within these seven counties. The notice was posted publicly at the DETCOG office. The notice was posted on DETCOG's website with direct links in both English and Spanish on the homepage. The notice was posted in both English and Spanish on DETCOG social media pages (Facebook and Twitter). Notices were also be mailed, emailed, or faxed to identified housing advocacy organizations which are active within our region, including the Jasper Branch of NAACP, Texas Appleseed, Texas Low Income Housing Information Service, Texas Association of Community Development Corporations, and the Crockett Resource Center for Independent Living. In addition, the notices were sent to members of the DETCOG Board of Directors, which includes a Minority Representative from each county within the region. Notice of the public hearings was also posted in the Texas Register at the Texas Secretary of State website. Notices were also sent by mail, email, or fax to the following agencies: DETCOG Regional Housing Authority, DETCOG Housing Assistance Program, Hemphill Housing Authority, Jasper Housing Authority, Livingston Housing Authority, Newton

Housing Authority, Pineland Housing Authority, San Augustine Housing Authority, Woodville Housing Authority, Texas Department of Health/Human Services Offices in Polk, Sabine, and Tyler Counties, the Jasper-Newton County Public Health District, and Burke (Regional Mental Health Authority).

Even though no requests for special accommodations or communication needs were received, a Spanish language interpreter attended the meeting and was available to provide services if needed. The two hearings were held in ADA-compliant buildings.

2. Approval of Minutes

Minutes of the September 22, 2022, meeting were distributed for review. President Harbison asked for any questions or corrections to the minutes – there were none. Leroy Hughes made a motion to approve the Minutes, seconded by Joe Blacksher. Motion passed with all voting in favor.

3. Report on actions taken by Executive Committee since last Board Meeting

The Executive Committee has not met since our last Board Meeting. No action to report and no action necessary.

4. Public Hearing to receive input on an amendment to the Method of Distribution for Hurricane Harvey CDBG-Disaster

President Allison Harbison opened a Public Hearing to receive comments on the Method of Distribution Amendment for the Hurricane Harvey CDBG-Disaster Recovery Local Infrastructure program funds at 12:48 pm. Executive Director, Lonnie Hunt, provided more information on the subject. The MOD Amendment will reallocate declined and/or de-obligated funds totaling \$101,103.00. These are Community Development Block Grant Disaster Recovery Funds related to Presidential Disaster Decoration 4332-DR. His presentation covered the following topics: original allocation amounts and distribution factors, the citizen participation plan, eligible entities, the minimum allocation, the requirement to allocate at least a minimum percentage of funds to HUD-Most Impacted areas, and the requirement to meet the national Low- and Moderate- Income (LMI) objective. He asked for input on distribution factors, threshold factors, eligible activities, and the LMI requirement. Information was also provided on how to submit written comments. Following questions and comments, the public hearing was closed at 1:22 pm.

- 5. Review the Preliminary Financial Report for the quarter and year ending September 30, 2022 Copies of the financial report were distributed to Board Members. Executive Director, Lonnie Hunt, reviewed the report. The Finance Committee is recommending that the financial report be accepted as presented. (See action taken under Item 6.)
- 6. Review the Investment Report for the quarter ending September 30, 2022

 Copies of the investment report were distributed to Board Members. Executive Director, Lonnie Hunt, reviewed the report. The Finance Committee is recommending that the investment report also be accepted as presented. A motion was made by Leigh Porterfield to accept the Financial Report and Investment Report as presented. The motion was seconded by Bill Holder. Motion passed with all voting in favor.
- An information sheet about the employee wellness program were distributed to Board Members. Executive Director, Lonnie Hunt, went over the proposal to approve incentives for participation in employee wellness program. Under the proposal, effective October 1, 2023, employees Employees can earn an extra \$200 in their Health Reimbursement Account (HRA). This would provide a maximum of \$1,200 annual contribution to the employee's HRA, or \$1,400 for employees with dependent coverage. Participation is voluntary. An extra \$100 would be earned by completing an annual physical or wellness exam and tobacco affidavit, and another \$100 by completing two annual fitness challenges using the Healthy County/Sonic Boom platform and wearable devices. Leroy Hughes moved to approve the recommended incentives. The motion was seconded by Joe Blacksher. Motion passed with all voting in favor.
- 8. Consider adoption of the Housing Choice Voucher Program Payment Standards to be effective December 1st, 2022
 - Copies of the Deep East Texas Regional Housing Advisory Committee meeting minutes, the Fair Market Rent for each county as determined by HUD, and our proposed Payment Standards for each county were distributed to Board Members. Regional Housing Authority Director, Janett Lewis, reviewed the Housing Choice Voucher Program Payment Standards and stated that the Housing Advisory Committee has approved the payment standards. Below, I have provided several suggestions for the MOD Amendment

- 1. Given the need for individuals within the DETCOG region to reenter the workforce in a post-COVID environment, I suggest the money be divided on a pro-rata basis by population for scholarships to individuals who are below 150% of AMI for their county. This plan could cover costs up to a dollar amount (e.g. \$2,500) to cover the cost of a course leading to the attainment of an industry-recognized certification.
 - a. An alternative would be for the equal distribution of the money between the counties.
- 2. An alternative plan could be to establish a technology grant for those who wish to enter the workforce, complete school, etc. This grant could provide up to \$500 of equipment per household for the acquisition of a computer and/or broadband internet. Recipients of the grant may choose to work from home or use the hardware to gain employment with a local employer.
 - a. Work from home opportunities will be vetted and would qualify for the higher end of the grant given the additional requirements the remote employer may impose b. Like the first suggestion, the counties could be allocated an amount based on their population or equally.

I'd love to hear your thoughts about these recommendations, but in my opinion, this could stretch these dollars and create tangible impact with the communities DETCOG serves.

This well is ruining my appliances. When it's cold weather pipes freeze and burst because it's to high in the air. My neighbors do not have this problem.



H-GAC hosted a public planning meeting November 9, 2022, to provide information, answer questions, and take feedback. H-GAC sought public comment on the reallocation amendment. Public comment was accepted by email, phone, postal mail, through an online portal, and at a public hearing on December 6, 2022. No changes were made following the public comment period ending December 15, 2022.

At their regularly scheduled meeting on January 17, 2023, the H-GAC Board of Directors approved the amendment for submittal to the Texas General Land Office for approval. This meeting was open to the public.

Subsequent to the Board approval, H-GAC confirmed that the counties of origin indicated in step 1 of the reallocation process would all accept the reallocated funds, eliminating the need for step 2. The final reallocation of funds is represented by the amounts and recipients indicated in the table for Step 1.
