## Agencies are recognizing the need to transform community engagement...

#### Needs/Actions

- a. Identify Local Vulnerabilities, Priorities and Decision Points
  - a. Ask, Listen, Record, Consider, Incorporate, Be Accountable
- b. Align Scales of Action, Information and Feedback
  - a. Downscale, Lower Barriers, Adapt Practices, Feed Decision Points, Be relevant, Comprehensible, Actionable, Credible
- c. Frame around shared/existing Vulnerabilities and Priorities
  - a. Center on Community Priorities, Let go of Assumed Priorities, Avoid Conflicted Frames

- d. Be an Honest Broker/Policy Entrepreneur, Span Boundaries, Build Bridges
  - a. Never over/under state risk, Boundary Spanning Partners
- e. Engage in Co-Production of Knowledge in Learning loops
  - Establish trusted collaborative spaces for knowledge sharing, Build Strategies Together

# Texas CAC Workplan What we've planned to do

#### TX CDBG-MIT CAC Working Groups Engagement & Communications, Guidance & Impacts

#### Committee Terms:

- Committee began March
   2021
- Co-Chairs will remain 4 years (to Spring 2025)
- Working Groups will complete their products within 2 years (by Fall 2024)
- Two-thirds of committee members may rotate off after Working Groups complete their work
- One-third of committee members requested to remain through Fall 2025, for continuity as new Co-Chairs and members join
- At least one committee member may be asked to continue serving as a new Co-Chair

#### Working Group 1: Linking to Local Communities

**Output**: Plan/guidance on communicating and engaging with communities

- Identify and connect with existing networks in local communities for two-way information exchange (e.g., faith-based, schools, libraries, civic organizations).
- Establish citizen communication channels for ensuring the equitable sharing of information on GLO programs.
- Develop consistent processes for updates from GLO to be distributed through communication networks, including in collaboration with the Committee.

#### Working Group 2: Application Guidance

**Output**: FAQs for *community and individual* applicants from end-user perspective


- Review existing Frequently Asked Questions to identify reoccurring questions and issues to create a standing guidance manual for applicants.
- Identify common application issues that delay review or lead to denials. Issues could include applicant errors or system improvements.
- Identify what kinds of information should be included by community or individual applicants to submit more competitive applications.

#### Cross-Cutting Activity: Understand Impacts of GLO Programs

**Output**: TBD – perhaps a database or adding to existing databases

Review existing GLO data related to expenditures of CDBG-DR funds and stakeholder data to look for areas of
opportunity for future programs. Issues to investigate include how to foster self-sufficiency for communities,
identify local data that would better reflect vulnerability on the ground, and how to implement mitigation
activities that serve more than one hazard.
